INVITATION FOR SEALED BIDS/SEALED QUOTATION

1. **Office of the Municipal Executive, Pyuthan** (OSDM, Pyuthan) has received funds from Government of Nepal for the construction of “**Ek Wada Ek Namuna Sadak**” as specified below and intends to apply part of the funds to cover eligible payments under the Contract as specified in the table below. Bidding is open to all eligible Nepalese Bidders.
2. The OSWM Pyuthan invites sealed bids/quotation from registered eligible bidders for the construction of **Ek Wada Ek Namuna Sadak as specified below.**
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Swargadwari Municipal Executive, Pyuthan telephone no. 086-400115** or may visit PPMO website www.bolpatra.gov.np.
4. A complete set of Bidding Documents may be purchased from the office of **Swargadwari Municipal Executive, Pyuthan** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, Vat registration and tax clearance certificate (2074/075) and upon payment of a non-refundable fee of **NRs 3000.00 till 14:00 Hrs on 2075/11/04 (2019/02/16)**. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. **NRs 500.00**. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account and bid security amount shall be deposited to deposit account of municipality as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall not be held.
6. Sealed or electronic bids must be submitted to the office of **Swargadwari Municipal Executive, Pyuthan** by hand/courier or through PPMO website www.bolpatra.gov.np on or before **12:00 Hrs on 2075/11/05 (2019/02/17)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs on 2075/11/05 (2019/02/17)** at the office **Swargadwari Municipal Executive, Pyuthan**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as specified below on table**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2076/03/01 (16th Jul 2019)**).
8. If the last date of pre-bid meeting, submission and opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission. And for purchasing if the last date of a bid falls on a government holiday then purchasing date shall close a day before such day. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
9. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of

- Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non responsive.
10. The bidders who submit bid electronically are requested to submit all the original hard copy bid documents within 7th day after bid submission date by post or any other way at Office Of Swargadwari Municipal Executive, Pyuthan . Failure to submit the original hard copy shall be ground for declaring the bid non responsive.
 11. Other things not mentioned in this notice will be in accordance with the prevailing Public Procurement Act, 2063 and Public Procurement Regulation 2064.
 12. The employer reserves the right to accept or reject, wholly or partly, any or all the bids without assigning reason, whatsoever.
